Resolution 08-90 Contract with NFL Properties, LLC

Mrs. Grice moved and Mr. Stern seconded a motion to approve the contract with NFL Properties, LLC in reference to the use of the Panther trademark:

NFL Properties LLC ("NFLP") is the exclusive representative of the National Football League ("NFL") and its thirty-two Member Clubs, including Panthers Football LLC (the "Carolina Panthers Club"), for the licensing and protection of their names, logos, symbols, and other identifying marks.

The Carolina Panthers Club has developed strong trademark rights in its PANTHERS and CAROLINA PANTHERS marks. The extensive use and promotion of goods and services offered by the Carolina Panthers Club in conjunction with these marks has made these marks famous and has engendered immense goodwill and strength.

It has come to our attention that Little Miami Local School District (by assignment from Little Miami Athletic Booster Club) ("LMLSD"), has filed an intent-to-use application (Serial No. 77/028,402) seeking to register the mark LITTLE MIAMI PANTHERS in the United States Patent and Trademark Office in International Class 25 for "Coats; Gloves; Hats; Scarves; Shorts; Sweat pants; Sweat shirts; T-shirts; Vests." We are concerned that the similarities between the Carolina Panthers Club's famous PANTHERS and CAROLINA PANTHERS marks and LMLSD's LITTLE MIAMI PANTHERS mark may cause the public to mistakenly believe that LMLSD's services are authorized or sponsored by, or are somehow affiliated with the Carolina Panthers Club.

As we discussed, NFLP, has filed a request for an Extension of our Time to Oppose application Serial No. 77/028,402. We would like to resolve this matter in a mutually agreeable manner.

As such, NFLP will consent to LMLSD's use an registration of the LITTLE MIAMI PANTHERS mark for the goods covered by application Serial No. 77/028,402 and in the form covered by that application provided that LMLSD agrees that:

- 1) LMLSD will not use or employ, in any manner or form, on any product or in any promotions and/or advertisements or on any Internet web site, any designations and/or indicia, including, but not limited to LITTLE MIAMI PANTHERS, which, separately or in combination, create a commercial impression of sponsorship, affiliation, endorsement, association, licensing, approval or other connection to the NFL, the Carolina Panthers Club, and/or the other Member Clubs of the NFL, including without limitation: (a) use of the name, likenesses, or other identification of any past, present, or future NFL football player; (b) use of any identification of the Carolina Panthers Club, such as "Carolina," "Charlotte," or any of the Carolina Panthers Club logos; (c) promotions of any products or services in connection with the sport of professional American football or use of any of LMLSD's marks in connection with the sport of professional American football; (d) promotion of any products or services at any venue where the sport of professional American football is played or use of any LMLSD's marks at any venue where the sport of professional American football is played; (e) use of any professional American football indicia on any products or in connection with any services; (f) manufacturing, promotion, advertising, marketing, or sale of any products or services that are specifically targeted toward the sport of professional American football or to professional players of the sport of American football:
- 2) LMLSD will not use its LITTLE MIAMI PANTHERS mark in the colors blue or silver, or in any combination of any of these colors, including the color combinations of blue and silver, blue and black, silver and black, or blue, silver, and black;
- 3) LMLSD will cooperate in the Carolina Panthers Club's efforts to obtain registrations for its PANTHERS and CAROLINA PANTERS marks and variations thereof, including without limitation, the execution of consent agreements;
- 4) LMLSD will not object to, oppose, or challenge the Carolina Panthers Club's use, application to register, or registration of its PANTHERS and CAROLINA PANTHERS marks and variations thereof and will take no actions adverse to the Carolina Panthers Club's efforts to obtain registrations of its PANTHERS or CAROLINA PANTHERS marks and variations thereof, including without limitation, the commencement of an opposition proceeding; and

5) LMLSD will always use its LITTLE MIAMI PANTHERS mark in the manner such that the words "Little Miami" or "Ohio" are prominently used in connection with the word "Panthers."

If LMLSD agrees to the terms set forth in this letter, please ask a representative of LMLSD to sign and date the enclosed extra copy of this letter and return it to me at the address on the letterhead to acknowledge its agreement to these terms. I look forward to discussing this matter with you and to hopefully reaching an amicable resolution to this matter.

Athletic Director

Position Status: Full Time/Flexible Schedule According to Event Needs

FLSA Status: Non-exempt

Evaluation: Performance of this job assignment will be evaluated annually in

accordance with provisions of the Board's policy.

Qualifications:

 Must be proficient in painting, carpentry, plumbing, minor electrical work, power hand tool use, minor mechanical repairs, preventive maintenance, lawn and shrub care, housekeeping, athletic field maintenance, athletic field repair, athletic field markings, athletic game and practice set-up.

- Must be able to operate (use) and maintain job related vehicles, equipment and tools.
- Must be physically able for manual labor including lifting heavy objects and climbing tall ladders or work from lifts.
- Must be a conscientious and independent worker and be able to adapt to a flexible schedule.
- o Be able to read and write, be of good moral character and demonstrate honesty in all situations.
- o Must be organized and keep required records.
- o Possess good people skills and ability to communicate.
- o Have ability to assume responsibility and make decisions.

General Description:

• Will be responsible for the care and upkeep of all outdoor athletic facilities at the High School and Junior High School complex and the main gymnasium complex at the High School. Must consult with the Athletic Director on a daily basis. Additional maintenance and custodial duties may be assigned at other locations as needed.

Examples of Essential Functions:

- Set-up for events, care and upkeep of main gym complex including chairs, scoreboards, p.a. system, bleachers, restrooms, locker rooms, showers, offices, etc.
- o Keep the grounds/gyms/premises neat and clean.

- Adjust the work schedule in the winter to work the inside scheduled contest as the custodian on duty.
- o Adjust the work schedule in the fall to help with the custodial clean-up duties.
- o Grounds maintenance of all athletic fields (seeding, fertilizing, mowing, aerating, weed control, watering, grading, top dressing, etc.)
- Obtain and keep current license/certification for application of chemicals/fertilizers etc.
- Prepare (including final mowing, lining etc.) athletic fields (i.e. football, baseball, soccer, tennis practice etc.) for practice and play according to schedules.
- Care and upkeep of all district properties located on or near fields (visitors restrooms, bleachers, stands, seating, track, dugouts, press boxes, storage buildings, etc.)
- o Care and maintenance of equipment and tools.
- o Demonstrate regular and predictable attendance.
- Display a positive attitude and enthusiasm in the position to help foster good public relations.

Other Duties and Responsibilities:

- o Care and upkeep of all athletic buildings and grounds as assigned.
- Work flexible hours and days as assigned, and as weather dictates (mow when it is dry, athletic field care, clean-up, security, as practice and games are scheduled or as assigned etc.)
- o This is a floater type position. Must be willing to adjust the eight hour workday to meet the needs of the athletic seasons.
- Conduct periodic inspection of assigned facilities for safety and preventive maintenance.
- Maintain an inventory and control of stock for custodial and maintenance supplies.
- Serve as a role model in how to conduct themselves as citizens and as responsible intelligent human beings.
- Help instill the belief in and practice of ethical principles and democratic values.
- o Conduct other duties related to grounds/floor maintenance as assigned by the superintendent, director of support services or the principals.

Knowledge, Skills and Abilities:

Must be proficient in painting, carpentry, plumbing, minor electrical work, power and hand tool use, minor mechanical repairs, preventive maintenance, minor roof repairs, lawn and shrub care, athletic field care markings and housekeeping. Must be able to safely operate (use) and maintain vehicles, equipment and tools. Must be adept at small engine repair. Must be a conscientious and independent worker able to adapt to a flexible schedule.

Equipment Operated:

Maintenance vehicles, power and hand tools, tractors, fork lifts, floor care equipment, ladders and lifts, HVAC cleaning and maintenance tools, operate the computer athletic field watering system and lining equipment, scoreboard and public address system, and other equipment assigned or necessary to performing the assigned work.

Additional Working Conditions:

- o Occasional exposure to blood, bodily fluids and tissue.
- Occasional operation of a truck or vehicle under inclement weather conditions.
- Occasional interaction among unruly children.
- Occasional extreme working conditions caused by extreme weather conditions.
