Mr. Gonda provided an analysis of the athletic pay to participate model for the 2011 fall sports. While revenues are coming in below the estimates due to a slightly lower participation rate, the overall projection for the year at this point is the model is still in the position where revenues will exceed expenses by year end.

Mr. Gonda also noted the 2010-2011 district's per pupil expenditure amount was \$7,959 which is in the lowest 3.1% of all 613 school districts in the state.
