Five-Year Forecast

Mr. Gonda spoke to the Board regarding the district's five-year forecast for the May submission. It was based upon known relevant factors as of 5/18/15 and with the knowledge that it is a work in progress. He stated that the revenues were looking to remain relatively flat. Property values have been decreasing over the last few updates (2012-4.05%, 2009-8.37%), however, they appear to have stabilized and there is an increase in new construction. He further said that Little Miami is projecting a slight increase in valuation in the next triennial update of 3%. Property tax collections (including public utility personal property and property tax allocations) should remain consistent throughout the forecast. Unrestricted Grants in Aid (State Funding) is projected to remain flat at this point. The upcoming biennial budget Sub HB64 is still going through the legislative review process.

For expenditures – Personnel services – staffing will be evaluated and added if needed as the enrollment continues to grow. Fringe Benefits – consists of retirement and health insurance. Medical insurance for the district is dropping 1% for FY16. This is due to having a high deductible health plan and also low claims through our consortium. Fiscal years 2017 and after have a projected increase of 12% for health insurance. Purchased Services consists of utilities, repairs, tuition etc. One of the main drivers is open enrollment and community schools which are expected to remain flat going forward. In addition, in FY16 there is a projection for the purchase of digital curriculum.

Capital Outlay – consists of items that have a life of 5 years or more. FY'16 includes projections for additional technology and also four new buses.

The passage of the emergency operating levy in 2011 has had a significant effect on the district with regards to finances and school offerings as it encompasses approximately 26% of the current operating budget. The renewal of the emergency levy is vital going forward to maintain current offerings by the district.
