PAYMENTS/BALANCE INFORMATION

Parents can set up an account with EZPay at www.spsezpay.com/LittleMiami/login.aspx. Only email addresses are required to register for EZPay services. You will also need each student's six digit student ID number. EZPay can be used to make payment to student's lunch accounts with electronic check and credit cards.

PAYMENTS AT THE REGISTER

Cash and check payments are accepted at school. Elementary students should have money in an envelope with the student's name on it. Lunch money should be turned in to the teacher or given to the cashier at breakfast. To keep lines moving quickly we do not give change back. Any surplus money will be added to the account for future purchases.

FOOD ALLERGIES and NUTRITIONAL INFORMATION

If your student has a *life threatening* food allergy, please fill out the form in the Food Service Handbook and provide documentation from your doctor. The Food Service Handbook will be available on the Little Miami Schools website under the Food Service tab. A doctor's note is required for meal modifications. You are also welcome to call Rachel Tilford, Food Service Director, to discuss dietary needs.

All menu items and snacks offered by the Little Miami Child Nutrition Department are free of peanuts and tree nut. However, students may pack these items in lunches brought from home.

CHARGES

Elementary students are allowed three meal charges or up to \$8.00. Once a student has reached the charge limit they will be served a cheese sandwich with a fruit, vegetable and white milk.

Intermediate and Junior High students are allowed two meal charges or up to \$8.00. Once a student has reached the charge limit they will be served a cheese sandwich with a fruit, vegetable and white milk.

High School students are allowed one meal charge and must bring the money the next day. Only one alternate meal of a cheese sandwich, a fruit and vegetable serving and white milk will be provided.

Families are responsible for negative balances due to charging. Negative balance calls for each student with a negative balance on their lunch account will be made by School Messenger on Mondays, Wednesdays, and Fridays every week except when school is out. To avoid receiving many calls please strive to keep accounts positive.

FREE AND REDUCED PRICE MEALS

Free or reduced priced meals are available to families who qualify. A simple online application available at https://littlemiamilsd.sdms2.com. Paper copies of the application are available at each office and an electronic document is posted in the Food Service tab of the school's website. Only one form per family is needed to apply for this program.
