Communications and/or Visitors to the Board

Mr. Power gave a brief update on the weight room status. He asked Athletic Director Tiffany Sawyer how soon before the new weight room would be in full usage. She stated that everything had been moved out of the old weight room and the athletes are currently working out in the new weight room.

Mr. Gonda gave an update on gate receipts through the winter season. He stated that the district was \$1,400 behind estimates but felt optimistic for the spring season. Winter gate receipts were up 20 percent. Winter sports participation was also up, mostly due to a large increase the number of students who participated in bowling. Junior High boys' basketball was also a big addition. Mr. Gonda and Ms. Sawyer are working to find ways to lower pay-to-participate fees. They may have more information for the Board in the coming months.

Curriculum Director Regina Morgan gave an assessment update. She said that the district was at the end of its assessment window now. She confirmed that next year's testing would be all online. Round 1 window is scheduled to run March 14 through April 15, 2016, and the End-of-Year assessments are scheduled to begin April 18, 2016. She said she was not pleased to discover that the last unit in the PARCC EOY assessment included a student survey. She said asked PARCC support for a copy of the survey but was denied access due to the possibility of teachers influence on the student responses. Mrs. Morgan said that administering a third party student survey without first getting approval from a parent/guardian violates board policy therefore the administration decided not to participate in the survey. She said it appeared this survey was marketing research for Pearson. Mr. Haas said he would like to see if the district had any other options for next year and wondered what the fallout would be if we did not comply with the State. Mr. Niemesh then read a statement and said that he feels that the board needs to take a stand. He further said that the schools need to take back local control over testing. He will be sending a letter to ODE and PARCC regarding assessments. Mr. Power said he is going to do some research on these issues and report back to the board his findings.

Board of Education Recommendations
