The most notable changes are the elimination of the director of curriculum and the principal of Maineville Elementary positions and the addition of a junior high school assistant principal. The short-term solution for curriculum is to shift to a site-based approach utilizing the building principals with the superintendent providing additional support.

Mr. Gonda provided a year-end analysis of the athletic pay-to-participate model. While revenues came in below the estimates, expenses also came in below estimates. The low expenditures offset the low revenue, leaving the model in the position where revenues exceeded expenses.

RESOLUTION DECLARING IT NECESSARY TO LEVY A TAX IN EXCESS OF THE TEN-MILL LIMITATION

NOW THEREFORE BE IT RESOLVED by the Board of Education of the Little Miami Local School District:

SECTION 1. That the amount of revenue which may be raised in this school district by all tax levies which this school district is authorized to impose, when combined with all revenues to be received from the State of Ohio and the Federal Government, will be insufficient to avoid an operating deficit for this school district.

- SECTION 2. That pursuant to the provisions of Section 5705.194 of the Ohio Revised Code, it is necessary that a tax be levied in excess of the ten-mill limitation for the benefit of this school district, for the purpose of avoiding an operating deficit for the Little Miami Local School District, in the amount of \$10,638,795 per year for a five (5) year period.
- SECTION 3. That the question of the passage of said tax levy shall be submitted to the electors of the school district at an election to be held on November 8, 2011. If approved by the electors, said tax levy shall first be placed upon the 2011 tax list and duplicate, for first collection in calendar year 2012.
- SECTION 4. That the treasurer of this board of education be and is hereby directed to certify forthwith a copy of this resolution to the county auditor at least ninety-five (95) days prior to said election as required by law requesting that said county auditor calculate and certify to this board of education the total current tax valuation of the school district and to calculate the annual tax levy which will be required to produce the annual amount set forth in Section 2 hereof, in accordance with Section 5705.195 of the Ohio Revised Code and Section 5705.03 of the Ohio Revised Code.
- SECTION 5. It is found and determined that all formal actions of this board of education concerning and relating to the adoption of this resolution were adopted in an open meeting of this board of education, and that all deliberations of this board of education, and of any of its committees that

resulted in such formal action, were in meetings open to the public, in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code, and the rules of this board of education adopted in accordance therewith.

FOOD SERVICE POLICY

In accordance with SB 210

RESTRICTIONS ON COMPETITIVE FOOD AND BEVERAGE SALES IN SCHOOLS (R.C. 3313.814(A), 3313.816, 3313.817, 3314.03(A)(11)(d), and 3326.11; Section 3)

Beginning July 1, 2011, LM Schools adopts the following restrictions regarding a la carte food and beverage sales to students:

The LM Nutrition Standards for Food and Beverages Sales, restricts the sale of certain foods and beverages during the regular school day, as well as during periods before or after the school day in which students are participating in school-sponsored extracurricular activities, academic or enrichment programs, or latchkey programs.

The restrictions apply only to "a la carte" items, which are individually priced food and beverage items available for sale to students through the school breakfast or lunch program, vending machines located on the school property, or a school store.

JH Cafeteria 7:05-8:00 AM; 10:00 AM – 12:00 PM

IS Cafeteria 8:30 -9:00 AM; 11:30 – 1:00 PM Salem Cafeteria 8:45 – 9:15 AM; 11:45 – 12:45 PM

The restrictions do not apply to food or beverages that are part of a complete meal provided through a federally subsidized breakfast or lunch program and are being sold individually in a serving portion of the same size as in the complete meal. They also do not affect foods and beverages sold in connection with a school-sponsored fundraiser or other event held outside of the regular school day or in conjunction with an interscholastic event. Food provided free as refreshment for parties, potlucks, teacher appreciation luncheons or breakfasts, etc, is not subject to district nutrition standards. However, LM Schools would like to encourage all of these district- affiliated groups and organizations to follow these restrictions whenever possible. Finally, they do not apply to vending machines that are accessible only to staff members.

CONTRACTS WITH FOOD OR BEVERAGE VENDORS (Section 4)

If LM enters into an exclusive contract with a vendor supplying food or beverages, the contract must comply with these A la Carte Food or Beverage restrictions and standards.

PLACEMENT OF VENDING MACHINES (R.C. 3313.814(C))

LM Schools prohibits the placement of vending machines in classrooms where students are provided instruction.

EXCEPTIONS:

- Where the instructional space is also the space where students are served meals; and
- Vending machines that sell only milk, federally subsidized complete meals, or food and beverage items that are part of a federally subsidized complete meal and are sold as individually priced items in serving portions of the same size as in the complete meal, may be placed anywhere.
