### Communications and/or Visitors to the Board

Mrs. Morgan gave a presentation on the Straight A Grant. These grants are awarded from the state of Ohio for projects that fulfill important goals related to: student achievement, responsible budgeting, and shared resources. Mrs. Morgan proposed a New Learning Center design that would create student opportunities such as virtual field trips, online instruction, dual-credit, after school tutoring, as well as opening an Adult Learning Center for our community.

Mr. Gonda gave an update on pay-to-participate fees for the winter sports season. He said that the new model is working correctly. The district has added teams due to the increase in participation. Last year, 119 students participated and this year there were 222 students. Winter (basketball & wrestling) gate receipts were up 11.4%. He will give a spring season update in June.

Mr. Power updated the Board on the current status of legislation that allows districts additional calamity days. He said the bill was passed on March 12. The district will have four days to make up for the 13-14 school year. He has decided to add on the days in June versus adding a half hour to the remaining days due to the fact it would cost the district additional money.

Mr. Power congratulated the School Board for receiving the Gold Award, and Stephanie Woodruff for being named Cincinnati Teacher of Excellence.

Mr. Power also gave an enrollment update. He is projecting 200 new students for the 2014-2015 school year, which could push enrollment to its highest level ever.

Mr. Power announced that Little Miami received a \$30,000 grant to be used for the security upgrades in the entryways of the buildings.

Mr. Cremeans reminded everyone about the upcoming Board listening session at Harlan Township Fire Department.

Ms. Grice presented a certificate to Mr. Power from the Ohio School Board's Association for his nomination as Superintendent of the Year.
