Resolution 07-006 Directing the County Auditor to Levy a Tax Outside of Ten Mill Limitation

Ms. Grice moved and Mrs. Hamburg seconded a motion to adopt the following resolution:

WHEREAS, at an election held on May 2, 2006 there was submitted to the electors of the Little Miami Local School District, Warren County, Ohio, under authority of the laws of Ohio and Section 5705.194, Ohio Revised Code, the question of levying a tax for the purpose of issuing debt for new construction and renovations and improvements, in the sum of \$62,500,000, and a levy of taxes to be made outside of the ten-mill limitation estimated by the county auditor to average 6.15 mills for each one dollar of valuation, which amounts to .615 cents for each one hundred dollars of valuation, for a period of twenty-eight (28) years, as provided by law; and the Little Miami Board of Education, after having canvassed the returns of said election as certified by the Board of Elections, finds that four thousand, six hundred and sixty-seven (4,667) votes were cast in favor of making such levy and four thousand, eighty-eight votes (4,088) against said levy and that said question carried; and

WHEREAS, the tax budget for said district for the current fiscal year has been prepared and is now in the hands of the county auditor;

NOW, THEREFORE, BE IT RESOLVED by the Little Miami Board of Education, Warren County, Ohio, that there is hereby levied on the taxable property of said district of a tax of four and twenty-five hundredths (4.25) mills on each dollar of valuation of a tax of forty-two and one-half cents (.425) on each one hundred dollars

(\$100.00) by said auditor, that a copy of this resolution be put into the hands of said auditor forthwith by the Treasurer of said Board of Education for his information and action, that the county auditor be requested to correct the tax budget, as required herein, to include said levy and to distribute the proceeds to the credit of the Debt Service Fund of said district for current expenses.
