The board discussed the alternative bids to the contract that would move plumbing and/or electrical service above grade at Salem Twp. Mr. Power said that moving the plumbing above grade may eliminate the issues of leaks affecting electrical service at the building, and that may, in turn, eliminate the need to move the electrical service.

Mr. Gonda and the Board discussed the need for further study of the use of permanent improvement dollars prior to moving ahead with awarding the contract for replacement windows at Harlan-Butlerville.
