#### Work Session

Ms. Boron led the Board through a proposal to refurbish and/or finish the interiors of suites at the Maineville Crossing facility. This proposal included information on what district offices would be located in the large, currently unfinished portion of the building, and which offices would be located in the existing suites. The plan included offices, storage areas, a technology/server space, public spaces and a board meeting room. Ms. Boron also discussed the phases of moving personnel into these spaces. Mr. Power said that he would like to move some core staff into the space as soon as possible to free up spaces in school buildings. Getting adequate internet service in the building would be key, as the treasurer's office and the EMIS coordinator needs a higher level of encryption than the "residential" internet currently available in the space.

Mr. Power said the district could not begin to do any work on the site until the master lease agreement with Clinton Memorial was terminated. He said the Board would see that and an additional services contract for Emersion on the Sept. 26 board agenda.
