Reduction of Pay-to-Participate Fees for 2018-2019

Mrs. Grice made a motion to approve a reduction in pay-to-participate fees beginning with the 2018-19 school year, with fees reduced by \$75 at the high school and \$50 at the junior high and the family cap realigned to reflect these changes. Motion died due to lack of second.

Mrs. Grice said she would like to discuss a smaller reduction than the one first proposed. Cutting the fees by \$50 at the high school and \$25 at the junior high would save enough dollars to pay for half a teacher's salary.

REGULAR SESSION 12/12/17

Mrs. Journeay said she would like to see it approved as recommended. She said she believed the pay-to-participate fees were too high and a reduction was long overdue.

Mr. Niemesh said he agreed and said he would like the fees to be brought into line with other league opponents (Little Miami's were the highest.) He said a \$75/\$50 reduction is his preference, but that if fellow Board members could only support a \$50/\$25 reduction, he would not vote against it.

Mr. Haas said that if a \$75/\$50 reduction were to pass, he would insist that \$10,000 from the Mercy Health payment to the athletic department be used to defray the impact to the general fund. He said he would forego that request if the Board settled on a \$50/\$25 reduction. Mr. Niemesh said he did not want to touch the money from Mercy and wanted that to be up to the discretion of the athletic director to use.

Mr. Niemesh made a motion to approve a fee reduction of \$50 at the high school and \$25 at the junior high. Mrs. Grice seconded.
